PLACEMENT CONTRACT

This contract is made and entered into on this ____ the day of _____, 20____, by and between Neuse River Golden Retriever Rescue Inc. (hereinafter referred to as "NRGRR") and _____ (hereinafter referred to as "Adopter"). The Adopter wishes to adopt a dog from NRGRR, pursuant to the terms of this contract which are set forth below. Now, therefore, in consideration of a fee of \$_____ per dog (see Section 16), from the Adopter, the parties hereby agree as follows:

1. NRGRR agrees to allow _____ (insert dog's club name) to be placed with Adopter, and Adopter shall care for said dog humanely, including but not limited to, providing adequate food, water, shelter and veterinary care, both preventative and emergency related, The parties reasonably believe that the age of the dog, as of the date of this contract, is approximately _____ yrs./mos.;
2. Adopter shall spay or neuter the dog, if applicable, within two weeks of obtaining possession; unless spaying or neutering must be delayed because of the dog's medical condition, in which case the dog shall be spayed or neutered as soon as possible thereafter;
3. Adopter shall license the dog in accordance with the laws and ordinances of the jurisdiction in which the Adopter resides;
4. Adopter shall maintain identification by way of tags attached to a collar at all times and the collar must be on said dog at all times except when crated; further, if the dog does not have either an identifying tattoo or microchip implant, Adopter shall ensure that such permanent identification is placed on the dog within four weeks after obtaining possession and shall notify NRGRR of the tattoo or microchip number. If a microchip is implanted, Adopter agrees to register NRGRR as the primary contact for microchip and _____ [insert NRGRR vet name] will be identified as the pet's veterinarian; Adopter should be registered as the alternate contact;
5. Adopter shall not sell, trade or dispose of said dog in any way, but shall return the dog to NRGRR if at any time the Adopter wishes to relinquish custody for any reason;
6. Adopter shall not allow the dog to be used for any medical experiment or purpose whatsoever;
7. Adopter shall not keep the dog chained, tied, or confined to an outside pen, nor shall the dog be trained for attack purposes or used for fighting or breeding purposes;
8. Adopter shall not allow the dog to be free to roam the streets nor will Adopter transport the dog in the back of an open truck except within a dog crate;
9. It is agreed that NRGRR may examine and make inquiry about said dog at any time. If NRGRR determines, in its sole discretion, that the dog is being abused, neglected, or kept in conditions or in a manner not in accordance with the terms of this contract, the dog may be reclaimed by NRGRR immediately, with or without contacting the Adopter, and Adopter agrees to relinquish possession. No full or partial refund of the fee shall be due in the event that NRGRR reclaims the dog from unsatisfactory conditions, and Adopter waives any right that he or she may have to challenge the transfer of possession under federal or state law;
10. It is agreed that both the Adopter and NRGRR have a two week period from the time of the Adopter first taking possession of the dog to rescind this adoption contract for any reason. If the adoption contract is rescinded within the first two weeks of possession, a full refund will be given to the Adopter, and the dog will be returned to NRGRR. After the two week time period, if the dog is returned to NRGRR, the Adopter's fee will not be refunded;
11. The parties agree that no AKC or other registration is applicable to this transaction;
